therefore here is significant difference among the categories and there is positive impact of prevention of nationalist parties




Figure 1.1 Kuruskal-wallis H Test Curve Figure 1.1 is describing the region of the test statistic that at degree of freedom 6 the table value test statistic is 18.55 with specified level of significance 0.05 and calculated value for test
