childhood (Yunus, 2019). After her son's death she broke down and even not able to give enough love to her remaining children until she nearly loses Paul, her second son, from that time Paul has become the important part of her life, and they both seems to live for each other. Paul trapped in the love of Miriam leavers, who dwells near the Morel's family in form. They keep on very dedicated, but entirely spiritual relationship for many years. Mrs. Morel does not approve Miriam, because of which Paul does not in favor of marry her. He persistently flickers in his sentiments towards her. Paul intends to

meet Clara Dawes a suffragette who is separate from her husband through Miriam, as he fascinated to Clara and begins to talk about his kinship with Miriam. She tells him that he should consider effectuate their love and then return to Miriam to see how she feels. Paul and Miriam sleep together and are fleetingly gleeful, but pretty soon afterward Paul intends that he is not in favor of marry Miriam, and so he leaves her. Atarsia (2020), Mention that Freud aims to understand the reason behind individual acts. He introduce with psychoanalytic discipline the notion of personality in which he emphasizes on the unconscious part of the psyche that determines human conduct. John Steiner (1996) argues that the purposes of psychoanalysis are examined in expression of theories of rational occupation configuration. The theory of intellectual argument remains the central theory of traditional psychoanalysis but has been strengthened and complemented by newer theories. In notable theory of projective credentials has completely distorted our view

Ranjan (2020), Mention that many prominent poets have written poems on money including D.H Lawrence and Philip Lakin. The present paper is the result of the study of the poem of the D.H Lawrence and Philip Lakin on money. The paper endeavors to analyze and critically appreciate the poem to expose correspondences and differences in theme in term of the manner and estimation of money of the poets. One of the major similarities is both the poets talk about the ill effect of money and it is the resulting of trouble and enduring. In proportion to them there are so many things in the life other than money that go in making life significant and delightful. The poem gives

Mother's disappointment to happiness her matrimonial life led her to hammering her love into Paul, utilizing him, making her sub-serve her own need and repudiating him the right to his own autonomous life. Accordingly, the son's relation with other women established a catastrophic failure. The women with whom the Paul had relation sustained Part of the tormenting someway or other. Lastly, mother's decease made him desperate and left his life in nonexistence (Uddin, 2013).

Actually, like many contemporary writers, Lawrence is so close to us that any effort as estimating his importance is appropriate to be faded and corrupted by our personal likes and and character favoritism dislikes dogmatism. So Sons and Lovers is a self-portraying novel or we can say autobiographical novel, we find that DH Lawrence has given a valid and genuine records of his life and how he felt and experience in the company of his mom (Bhatia, 2021).

Neha (2013) Explode that kinship between man and the universe is of the significant themes of Lawrence novels. Uncontaminated kinship between man and the universe around assists man accomplish accomplishments. Man due to the tendency of his mind, sometimes, found fake kinship with compels of nature and universe, results in torments and disaster. For man, the woman, he loves and marries, is the contiguous representative of nature. For woman, her man is the closest representative of the universe. The currents study focuses on crucial correspondence between man and its surrounding include heavenly bodies like the sun, the moon and the other planets (Neha, 2013).

Hence, it was ego that realized her to kill her husband, is not socially acceptable way. Therefore, Sigmund Freud said that ego is the realistic part of personality that restrained us from the act and urges that created by id. The job of ego is to maximizing the pleasure of id and avoiding the punishment and guilt of superego. Furthermore, ego is the mediator between inner demands and external reality. Therefore, Mrs., Morel realized before had done something wrong. Similarly, in the same lines, above, we can contemplate the superego in the same character because she was very angry with her husband, she vanished the conflict between them respectively. Consequently, superego is that part of personality that

completes the urges and needs in socially acceptable way. Superego is like our parents that tells us what is bad and right. Therefore, in the same lines as Mrs. Morel took a good decision to finish the conflict with her husband is her superego.

In chapter two, once at late night Mr. Morel was out of home and his wife was waiting for him. She wanted to visit a doctor because the infant was ill. Therefore, she was very angry and talking to her that if he comes home, I will not talk to him because he is neglect and only engrossed in his drinking. According to Sigmund Freud, the desires and needs that have the immediate response to its fulfillment is id. Consequently, id is that aspect of personality that acts upon the pleasure principle. Similarly, we can observe the id aspect of personality in both characters at the same time because her husband is drunk and he is out of his conscious mind, therefore she hated him. They went to the place of interview and gave it. After, his interview his mother asked him to eat something in the restaurant. Hence, they went to hotel and sat down on the chairs in front of the table. They were waiting for the waitress while she was busy with other customer. Therefore, Mrs. Morel did not want to disturb her and decided to wait for her pleasure. Mrs. Morel was a religious character in the novel but sometimes she acts aggressively towards the different circumstance. According to Sigmund Freud, id is the pleasure aspect of our personality that acts immediately to fulfill its needs. Id is the psychic and instinctive energy that emphasizes humans to fulfill their basic needs but it does not care about the right and wrong, only satisfy its desires. Therefore, Mrs. Morel express aggressive attitude towards waitress because she was not taking order from them. Even though, the other customer who came long after them, she took order from him and brought him his pudding. Therefore, Mrs. Morel became aggressive and said "Brazen hussy!" said Mrs. Morel to Paul. "Look now, she is taking that man his pudding, and he came long after us." (Lawrence, p. 108)

The quotations, below denotes the id of Mrs. Morel because these lines shows her fascinated relationship with her son William. Therefore, she grabbed by his thoughts every times. Previously, William came home with his betrothed and was argued with her because she was not interested in reading book. Therefore, William said to his mother sarcastically about his betrothed that mother she even did not finish a book yet. He decided to give her a book in order to study it but she was even unable to interpret a single page while William was intelligent he can interpret a book completely. Mrs. Morel said to William in her defense that she can interpret a book but indeed, she was not able to comprehend. Therefore, they had contradictions with each other and this was the main reason that Mrs. Morel was worried about her son William. Hence, the attitude of Mrs. Morel towards her son was on the base of id. Sigmund Freud of the view, that id is the genius part of personality by birth that fulfills the basic needs. The Id is the instinctive and psychic aspect of our personality that does not care about right or wrong but only concern with the satisfaction of its needs and desires. Therefore, the particular lines according to Sigmund Freud show her id respectively. That is why; she said that "very well, my boy. Particularly, Mrs. Morel was a religious character and her husband was luxurious man. Therefore, she would like to meet the way that is socially acceptable in order to divert her husband to morality but at the last she failed in her intention which deflected her mind towards disappointed completely. Therefore, Sigmund Freud said that ego is that part of personality that acts upon the reality principle. Therefore, ego is considered the mediator between inner demands and external reality to maximizing the pleasure of id and avoiding the punishment and guilt of superego. Similarly, ego is that part of id that has been modified by the direct influence of the external world. Therefore, Mrs. Morel wanted to realize her husband from wrong doing he was not listen to her therefore, she said that "I wait" Mrs. Morel said to herself. I wait what for can never come." Alfy's mother Mrs. Anthony got hold of Mr. Morel and told the whole story about the William and Alfy's fight. Therefore, when Mr. Morel came home, he was very angry with William. He decided to punish William but his wife prevented him. Consequently, the attitude of Mrs. Morel towards her husband was on the base of ego because she decided to realize him from wrong doing. Similarly, the line below shows the ego of Mrs. Morel. According to, Sigmund Freud ego is the mediator between inner demand and external reality. The job of

ego is to maximizing the pleasure of id and prevents us from the punishment of superego. Furthermore, ego prevents us from the urges and desires that has created by id. Ego is that part of id that has been modified by the direct influence of the external world. Particularly, the line shows the ego of Mrs. Morel because she was intended to realize her husband to leave stale food for mice. Consequently, she said "you might leave it for mice and pay for it out of your next pint", said Mrs. Morel. (Lawrence, p. 88)

These quotations from chapter five show the ego of Mrs. Morel because her husband was working carelessly in the pit. He usually got injury on one of his body parts. Therefore, she fed up from his immature act respectively. Previously, one of the pit-lad came to Mr. Morel's home. He knocked at the door and Mrs. Morel responded him. Therefore, the research study finds the id aspect in Mr. Morel's personality. Hence, Mrs. Morel hated him in this despicable position. She always struggles to make his religious because his behavior and attitude was not socially dismissible.

Findings, Conclusion and Recommendation

The consideration of this study shows the elements of psychoanalysis theory in the leading characters Mr. Morel and Mrs. Morel in the novel of Sons and Lovers. The researcher has found id, ego and superego as the traits of personality in the character of Mrs. Morel. She is a moral character because she does not want to perform an action against her religion. She always tries to supervise her sons and husband in order to make them moral. She always fulfills her desires and urges in socially acceptable way. On the other hand, Mr. Morel is hostile from his wife because he is immoral character throughout the novel.
