Metaphysical Objectivism in J.K.Rowling's Harry Potter and the Philosopher's Stone

Objectivism is a philosophical system worked out by the Russian - American writer Ayn Rand. She voiced her views on objectivism in her work "The Fountainhead" and "Atlas Shrugged" and later in her non-fiction essays and books. His intellectual successor, Leonard Peikoff, collected his perspective on objectivism in the lecture by Ayn Rand and published a book titled "Objectivism: The Philosophy of Ayn Rand". He has four ideas: metaphysics, epistemology, politics and economy. Moreover, he explores the ideas of art and government. Ayn Rand described her philosophy as "the philosophy of life". Supporters of Ayn Rand have shaped the institution for its philosophy and more websites to enlighten its philosophy.

Existence, awareness and identity constitute the fundamental objective axioms of philosophy. Metaphysical objectivism emphasizes the reality of the world by altering the basic axioms of philosophy. Taking a man to an object is inherent in acknowledging, in one form or another, that there is something that I am aware of. There is an existence — something — identity — consciousness. This is the underlying axiomatically concept recognized in the philosophy of objectivism (Leonard Peikoff, 7).

"Metaphysical objectivism is a view that there is a reality or kingdom of objects and facts, which are totally independent of the spirit" (metaphysics). With an independent mind, J.K. Rowling wrote the Harry Potter series, which was very famous throughout the world. For Ayn Rand, the primacy of existence is about to perceive or reflect on what exists. Whether we want something to happen or not, it's going to happen or it's not going to happen based on the evidence. This is the principle of the primacy of existence, and the primacy of conscience is about to be conscious of things through the perception of the senses.

In Leonardo Peikoff's book, Ayn Rand makes reference to the existence of one thing (primacy of existence). The existence of the base axiom is the primary axiom that something must be recognized. She taught in the lecture that if the thing has no existence i.e., it is a non-existent object, created by a writer; it arose after being written. The people of the same group or followers of this special writing will be aware that the non-existent object has entered into existence. People will know about these issues once this document comes out. In Harry Potter and the Stone Philosophal, Rowling presents so many nonexistent objects that transcend nature and reality. In the beginning itself, she introduced the object named 'Put - Outer', seemed to be like a silver cigarette lighter, which will observe the light and it can be turned on whenever a person wished to be. It was used by Dumbledore to put baby Harry at the home of Lily Potter's sister, after Harry's parents were murdered by Lord Voldemort.

Rowling, in his magical world, extends the wand to all witches and wizards to do magic, but with limitations. He never incorporates the magic world and the primary world, until he has to quarrel to steer the story. It establishes rules that witches and sorcerers should not use magic outside of Hogwarts, so if they use it, they will be expelled from school. It does not apply to the avoidance of end-of-life circumstances. Witches and sorcerers can make charms and other magical spells so that their desires come true. The wand is the most important thing in the land of magic. Harry buys his wand Ollivander's shop, where the wand maker will identify and analyze the quality of a person and according to their talents of magic; he will give the suitable wand for a person. Harry's wand consists of 13 and a half inches of Phoenix's pen, which also provides the pen for Lord Voldemort's wand, which killed Harry's parents.

The sorting hat will sort the new witches and sorcerers at Hogwarts' four houses, namely, Gryffondor, Hufflepuff, Ravenclaw Slytherin. The hat of sorting will sort the students in the houses by seeing the talents, the characters and the behaviors inside their heads of witches and sorcerers. Each home has its own qualities and features. The selection hat will talk and sing and present the houses with its qualities to the students. Students are ranked in all four houses by their skills and talents. Gryffindor house will have the students, who have a courageous heart, and they have boldness and chivalry. Hufflepuff's students are loyal and patient, and they are truthful and not afraid to work. The students at Raven's claw are ready to react and have spirit and learning skills. The House Slytherin will have the students, who have the real friends and they are crafty people in realizing their desires.

Ayn Rand speaks of a man's free will. But it must not negate the fact of reality by thinking beyond the reality. In Harry Potter series, J.K. Rowling writes about our own physical world which is the primary world and the natural people from the primary world to the beginning. In Harry Potter and The Philosopher's Stone, the Protagonist, Harry Potter led a normal life for ten complete years without knowing about the Hogwarts School and the world of wizards. Here J.K. Rowling included the primary world and the peoples' normal behavior and their routine life, to demonstrate that she does not deny the fact of reality. Then, her metaphysical thinking brought the novel to the next level of Harry's adventures on the Hogwarts School of Witchcraft which is hidden somewhere in London that people who are not magical are unaware of. Her power of imagination and passion for reading since childhood has made her think beyond reality with the free will of her conscience.

Consciousness is the primary factor for metaphysics. Because thinking differently made a writer to a metaphysical writer with his or her free will for consciousness. At this point, the free will for consciousness is not about the perception of a thing, but is to create a thing which does not exist (Leonard Peikoff, 24).

Albus Dumbledore invented the philosopher's stone, which will transform any metal into gold and whoever has the stone will live everlasting life. But Dumbledore made this stone with a bright spirit, that whoever wants to get the stone without using the mentality will be able to get the stone. Unicorn itself a fantasy element, has been used in so many fantastic stories of all time. Drinking the blood of a unicorn will also bring everlasting life according to Rowling in this novel. When Harry and his friend are detained for wandering in the corridor during night, while they come home from the hangover the dragon named Norbert to Ron the brother of Charlie, they are being punished for assisting Hagrid in the Forbidden forest. In the forbidden forest, Hagrid gives them the task of recovering the dead unicorn in the forest. Others searching it in the forest, Harry and Malfoy find it, drinking the blood of a Unicorn. While Harry sees this, creature, his scar starts burning heavy. Then he and Malfoy are saved by the half n animal and half a human being. Harry asks about that deed in Hagrid.

Forgetfulness is the nature of a man. But remembering the forgetfulness is pitiful. Rowling has created an object with full independence of consciousness, for knowing a person has forgotten something. The name of the object is 'Remember all'.

This object is a glass ball the size of a large marble that seemed to be filled with white smoke. Whenever a person who holds the Rememberall, forget something, the white smoke in the large marble will turn into scarlet red color to give awareness that he forgets something. Neville Longbottom receives the Rememberall from his grandmother, one day through the owl post. When he suddenly receives the memory, he turns into a scarlet red to warn him that hehas forgotten something. It is then torn off by Draco Malfoy during their first flight class with a broom handle. And Harry obtains it from him and returns it to Neville.
