It must play an important role in being a good role model in morality. Therefore, enhancing the management process, learn to deliver results to develop students to achieve their intentions the management of learning according to the Threefold Principles requires genuine cooperation from all parties [3].

The temple has been the center of community in Thai society since the past. The influence of Buddhism is an important factor in determining the way of life of Thai people. In particular, it is a collection of art, science and knowledge in many fields as well as a collection of valuable arts such as ancient monuments wall painting. These works of art are considered valuable cultural heritages and are like the uniqueness of the Thai nation. At present, the temple has more and more roles, that is, it is an important religious tourist attraction. When there is a request or various lawsuits occurred having to rely on the Sangha Act, it is a criterion for organizing the administration Sangha. of the administration of the Sangha is therefore regarded as the heart of the administration of the Sangha, namely administration, education, education, welfare, propagation, public utilities, and public welfare. to proceed in accordance with the Dharma and Discipline, the law, the Supreme Sangha Council's rules, resolutions, regulations or the Sangha Sangha Council and the Supreme Patriarch's orders [5].

In conclusion, any government must have and adhere to the rules as a criterion for the administration of the Sangha outside of the

Sangha, which is based on the Sangha Act, B.E. is the most important thing.

(nissaya sampanno), wise, competent (viyatta), disciplined (vinito), courageous (visaratho), and maintains the right things in the right place. should (Dhammanudhammapatipanno) and in accordance with the interview of Phra Thepsuwanmuni, P.D. 9, Assoc., Dr. Deputy Primate of Bangkok. In conclusion, consulting event various support. There should be opportunities for communities from all sectors to participate, give advice and help solve problems in all areas.
- 3. Educational welfare, there was an interview question. Do you think that the education of welfare. How is it appropriate for the leadership development model of the monks according to the plan to reform Buddhism in the Central Sangha Administration Area? It is consistent with the research of Phrakhru Pariyat Kittithamrong (Thongkhao Kittitharo) who researched Role of monks and temples in today's society. Results showed that Priests should be role models in moral matters should play a role in teaching, should be a good missionary preacher, should develop oneself in knowledge, both dharma and worldly understand the basics of the villagers should learn the law monastic rules and should be a giver rather than a receiver and consistent with the interviewPhrarajsutaporn, P.D. 7, Assoc. Dean the Faculty of Education Mahachulalongkornrajavidyalaya University In conclusion should allow the community to participate. There should be a meeting together

to find solutions and solve any problems that may arise. There should be ongoing counseling and educational assistance.

- 4. Dissemination, there was an interview question. What do you think, in the field of propagation, there should be activities to enhance learning according to the leadership development model of the monks according to the plan to reform Buddhism in the Central Sangha Administration Area? It is consistent with the research of Phramaha Sahat Thitsaro researched on Sangha organization management research study. Results showed that in the field of propagation in the clergy organization. They should be appointed and dismissed as a just and sequential authority until adaptation to the times and consistent with the interview of Phra Suwanmethaporn, Asst. Prof. Vice President for Academic Affairs Mahachulalongkornrajavidyalaya University. In conclusion, there should be a policy meeting. There are plans and assignments to match their knowledge and abilities, know the clear rules and regulations and should not aggravate the behavior of the coworkers when any problems arise.
- 5. Public utilities, there was an interview question. He thought that the public utilities according to the model of leadership development of monks according to the plan to reform Buddhist affairs in the Central Sangha Administration Area What should be generally appropriate? It is consistent with the research of Phramaha Thriti Wirotajano (Rungchaiwitoon) has researched on Model of development of monks for the efficiency of administration. The results showed that the public utilities should be developed according to the faith of the Buddhists by studying and planning the construction of things. within the temple to be suitable for the place according to the development of Buddhist principles such as Brahma Viharn 4, Sangkhahavut 4 and Sappurisadhamma 7 Phraudomsitthiyok, P.D. 9, Asst. In conclusion, there should be support and promotion of religious treasures for the benefit of the public, such as having a medical facility, organizing a security system organize a

He thinks that the public welfare aspect follows the pattern of leadership development of monks according to the plan to reform Buddhist affairs in the Central Sangha Administration What Area. should contributing to the community? It is consistent with the research of Suriya Rakkarsilp has researched on Roles of monks and economic of communities in dvnamics Nakhon Ratchasima Province. The results showed that Monks can offer good public welfare roles to communities in the area, believing in Buddhist principles by applying Buddhist principles for stability and sustainability. and consistent with the interview Phrakhru Opasonthakit, Asst. Prof., Dr. Primate of Bang Kruai District, Nonthaburi, in conclusion that the public welfare side be involved should congratulating the organization and community when receiving special awards or bonuses should hold an event to honor or publish the work.
- 7. Development of Phutthamonthon to be the center of Buddhism, there was an interview question. VI. Body of knowledge




Figure 1 Knowledge gained from research able to show the model of leadership development of monks according to the plan for reforming Buddhist affairs in the central Sangha administrative area as follows:

Administrative

- 1. Must adhere to rules as a criterion, other than adherence to the Sangha Act, B.E.
- 2. Adhering to the framework of the Dharma as the main principle is of paramount importance.
- 3. There is a creation and development of leadership in Buddhist personnel to be effective in managing the workload.

Religious Studies

- 1. Consulting event various support. There should be an opportunity for communities from all sectors to participate, give advice and help solve problems in all areas.
- 2. Education is the heart of monks and novices will be the world case or any fair case must be for the purpose of education that is only right so that they can live in the group peacefully.
- 3. Temples are considered centers of villagers and communities since the past with monks as teachers resulting in the word "bowon" houses, temples, schools, if any temples are ready and

operating. It should be worthy of communion in the sacrifice of the primate monks and guardians.

Welfare education

- 1. The monks are good role models in morality, play a role in teaching, be a good missionary preacher.
- 2. Develop one's self in knowledge, both Dharma and worldly.
- 3. There is a school located in the temple area or the area of that temple and the management of welfare education called the Sunday Buddhist Study Center.

Propagation

- 1. Any propagation or education, it must be well prepared and well rehearsed.
- 2. Issues of propagation because it is a duty. It is a courtesy, favor and reward for the patronage of Tayok Tayika.
- 3. It is the direct duty of the primate and guardian to comply with the framework of the Dharma and Discipline.

Public utilities

- 1. Develop according to the Buddhist faith by studying and planning the construction of things within the temple to suit the location.
- 2. Clarify the rules and regulations of public utilities that are consistent with the context of the Dharma and Discipline clearly and can be put into practice.
- 3. There is a good working system and quality perform duties strictly Always be strict on time. This will create motivation in the clergy circle. Public welfare
- 1. The Sangha Priest should study the plan to reform the Buddhist affairs in the Central Sangha Administration Area.
- 2. Sangha organization adheres to the good governance of the Dharma Discipline study the efficiency of personnel in the organization in accordance with the volunteer project.
- 3. Must take into account the principles of moral discipline and suitability for management in their roles and duties.

In terms of the development of Phutthamonthon to be the center of Buddhism.

1. The Sangha should have an organization or institution that is a unit linked to the

government sector, take care and take responsibility for efficiency to match the era.

- 2. Create SWOT macro participative incentives
- 3. Monks should play a role by suggesting initiatives to villagers taking into account the appropriateness and circumstance and not contrary to the discipline.

VII. Recommendations A. Recommendations for Practices

- 1. In organizing activities to promote personnel according to the model of leadership development of monks according to the Buddhist business reform plan in the Central Sangha Administration Area. The primate and guardian should clarify the rules that are consistent with the context of the Dharma and Discipline clearly and can be put into practice. There should be sincerity in planning and setting clear directions.
- 2. In organizing activities to promote personnel according to the model of leadership development of monks according to the plan to reform Buddhist affairs in the Central Sangha Administration Area Primate guardians should have a system of good and quality work. Refers to efficiency and effectiveness in administrative administration.
- 3. In organizing activities to promote personnel, a model of leadership development of monks according to the plan for reforming Buddhist affairs in the Central Sangha Administration Area Primate guardians should strictly perform their duties. Always be strict on time. This will create motivation in the clergy circle and should be a good role model responsible have a commitment to performing duties consistently and to incentivize the rulers appropriately.
- 4. In organizing activities according to the leadership development model of the monks according to the plan to reform the Buddhist affairs in the Central Sangha Administration Area Primate rulers should sacrifice their own interests and interests for the common good and always being generous to each other should be a parent who has patience when there are any problems affecting them, they do not show negative behavior to their subordinates.

B. Recommendations for Further Research

- 1. Should study the factors affecting the governance in the Sangha by using SWOT to apply in the organization.
- 2. It should be a comparative study of the factors that promote the leadership development model of the monks according to the Buddhist business reform plan in the Central Sangha Administration Area. in comparative sangha organizations, for example, according to the governance of the Dharma and Vinaya.
- 3. Should study the efficiency of personnel in the organization according to the model of leadership development of the monks according to the plan for reforming Buddhist affairs in the central Sangha administrative area, such as academic progress further education being a leader, etc.
- 4. Should study the application of Buddhist Dharma principles of personnel such as Brahmawihan 4, Sangkhahavatthana 4, Saraniyadhamma 6 and Sappurisadhamma 7, etc., to be used as a guideline for studying and governing the Sangha and continuing to practice learning according to the framework of the Discipline.

Results indicated that the level of a model of leadership development of administrative monks in the central region Sangha Administration according the Buddhist Reform Plan in overall had shown in more level.
