THE IMPACT OF INTERNATIONAL INTEGRATION ON THE PROCESS OF PROMOTING THE ROLE OF MASS MEDIA IN THE PREVENTION AND CONTROL OF DOMESTIC VIOLENCE IN VIETNAM TODAY

Abstract

Domestic violence prevention has been an important issue, which is of concern to the whole society. There are many measures put in place to prevent acts of domestic violence that are happening in Vietnam. The huge disparity in the

ability to hold information and communication will easily lead to the ability of these countries to impose cultural and ideological values on other countries, including family culture. And so, this is a limitation in promoting the synergy of the media in general and promoting the role of the mass media in domestic violence prevention in Vietnam in particular.
