The fall of the Suharto's administration in May 1998 that prompted the progress of majority

rules system has changed the current political request. The legislative issues value-based, vote purchasing, cash governmental issues, support and clientelism as discribed by some political specialists like (Allan, 2012, Aspinall, 2013, Aspinall, 2014, Aspinall and As 'Advertisement, 2015; Aspinall and As'ad, 2016; Hutchcroft, 2013; Feeds, 2013; Choi,

2011; As'ad, 2016). Along these lines, the genuine proprietor of the challenge phase of Nearby Head Decisions is to be political speculator contestation.

Political entertainers, don't work exclusively in Neighborhood Head Races but instead team up in an organized way with different on-screen characters. Everything that could possibly be viably done due to the plentiful financing support in the Nearby Head Decisions is an instrument of choosing and bringing forth political elites or neighborhood experts for validity, however the Neighborhood Head Races rather moved the importance of being the field of vote based rot. The universe of vote based system after fall Suharto's regims are tendre turn towards new tyranny in the pack of vote based system.

The ascent of the proprietor of the capital supporting in the Neighborhood Head Decisions to put their assets in the races since they accept will increase a wealth when the competitors who upheld it won. Political capital help to up-and-comers is willful, however not rarely as advances or obligations. For applicants who lose in decisions, in danger must restore the obligation. Someone needed to sell the property until it was sold out. Some even experience worry until there get insane because of obligation.

The Nearby Head Political race after political change, in reality simply just speak to the enthusiasm of ideological groups in a formalistic majority rule heavenly body and the Neighborhood Head Races loses considerable importance with control and trick. In opposite side, races are defenseless against being utilized by bureaucratic elites, particularly by occupants with certain modes: First, through the arrangement of social help (Bantuan Sosial) and award reserves. Second, make populist programs. Third, give monetary help to the regime/region which is the base of supporting the incumbency. Fourth, increment the pay recompense of administrators or Government workers in the areas. Fifth, dispense for the improvement of framework, for example, street development. 6th, misappropriation of town reserves. Seventh, penetrate the interests of officeholders in setting up the Planning Distribution for Neighborhood Developmen (Anggaran Pendapatan dan Belanja Daerah/APBD). Eighth, utilizing subsidizing wellsprings of distributions of nearby government exercises canvassed in the exercises of different offices , particularly advertising by introducing advetorial or news paying the planned incumbents in print media, hardware to on the web, paid at the rate per news or every month, with holding a broad communications that gives space or length to imaging or raises the notoriety and electability.

On account of Nearby Head Political race in Barito Kuala (Batola), Hasanuddin Murad, two priods of Head Legislature of Barito Kuala (2007-2017) who was transparently strong of his significant other, Hj Noormiliyani Aberani Sulaiman and his nephew Rahmadian Noor to be up-and-comer of Head Governmenet (2017-2021). This data originates from columnists or media activists, particularly Media Kalimantan in South Kalimantan. As an examination of the Region Legislature of Hulu Sungai Utara in the approach the 2017 races, it has dispensed distribution assets for bupati-bad habit official exercises of Rp 10 billion, a lot higher than the normal, for example, Hulu Sungai Selatan (HSS) 2 billion in APBD 2017.

The political organization has changed yet not changes in the conduct of political entertainers who despite everything carry on in pridatory theocracy (Hadiz, 2010). In this way, what's going on about democratization is for the most part constrained by political on-screen characters. The changing of governmental issues in democratization period isn't really joined by the fall of the intensity of the theocracy.

The quality of the theocracy has been decentralized to the nearby level and made due after fall of Suharto's regims in the democratization time that brought forth the difference in power organizations as a push to end the intensity of government and the act of nepotism through the nearness of new institutionalism for the structure of the intensity of new ruthless oligarchs at the neighborhood level by neighborhood actors.The issue of decentralization has commandeered neighborhood business people and political elites to assemble another theocracy by acing vote based establishments (authoritative and ideological groups) or setting followers in government (official) administrations. The issue of democratization emerges in view of the presence of ruthless force which turned into a
